REQUIREMENTS FOR I-20 ADMISSIONS

- ___(1.) **Official TOEFL (Test of English in a Foreign Language)** test result from ETS with a score of **450 minimum (written), 133 (computer based), or the Internet Based TOEFL (IBT) of 45 (No photocopy)**
- ___(2.) **Official bank letter/USCIS affidavit of support in the exchange rate of U.S. \$16,500.00.**
- ___(3.) **1 Official** high school diploma/transcript showing graduation.
1 Official college transcript (Non-English documents must be accompanied by translated copies.)
- ___(4.) One small **photograph** (passport size) with your name printed on back.
- ___(5.) International Student **Data Form** completed and signed.
- ___(6.) CRC Admissions **Application** completed with a #2 pencil and signed. (Do not submit on-line)
- ___(7.) **\$50.00 Non-refundable** application fee payable to Cosumnes River College in the form of a check, money order, or cashier's check (do not send cash) payable on a United States bank.
- ___(8.) Certification of Negative Tuberculosis Skin Test.
- ___(9.) Mandatory Health Insurance
- ___(10.) Mandatory **ORIENTATION** (after arrival)

*International students who have been attending school in the United States are also **REQUIRED** to submit the following additional items:*

- ___(10.) **CRC TRANSFER/RELEASE FORM** filled out & **SIGNED** by your International Advisor
- ___(11.) Copy of **VISA** stamp in your passport.
- ___(12.) Copy of **I-94** in your passport.
- ___(13.) Copy of your **current school's I-20** issued to you.

FILING YOUR APPLICATION:

HEALTH INSURANCE:

Health insurance is **required** upon registration and must be valid in the United States. All F-1 students are required to purchase the school's medical/health insurance or a comparable plan (in English) with coverage dates. **TRAVEL INSURANCE IS NOT ACCEPTABLE.**

EMPLOYMENT:

F-1 employment opportunities off-campus are **restricted** and on-campus employment is limited.

INCOME TAX:

Students must file a Federal Tax Return each year whether they worked or not. Please see Judy Kimura for details.

ON-CAMPUS HOUSING/DORMS:

NONE. It is the student's responsibility to find housing. There are apartment buildings within the vicinity of the campus as well as public transportation.

TOEFL:

(Test of English as a Foreign Language) TOEFL testing programs are given at set times during the year throughout the world. Information on dates, locations, and fees are available from their website at www.toefl.org

CRC ASSESSMENT TESTING:

ESL/ENGLISH/MATH TESTS ARE REQUIRED FOR ALL NEW STUDENTS. This is necessary to provide an up-to-date recommendation in your counseling session with the counselor to plan towards an AA/AS Degree and/or transfer of courses to a four-year institution.
